Hi Chris,

Way back in 1997 or 1998, I contacted Kinsolving, Chris Lee, to locate my birth son. I tried in vain for several years and only put out money to no avail. It was like in only day's that I heard back that they had located him, I sent the money, and had everything (and more) about my birth son for me to move forward. It was April 1, 1997 or 1998 that I made that first call to him, ended up sending snail mail letters, even a photo album and then we began e-mailing. I continued to be in touch with him over the years, sent birthday cards on his birthday, sent gift cards to him and his family at Christmas and was never going to be a bothersome to him. I let him take the lead and I'm so glad I did.

I finally, after many years of just e-mailing, got to meet my birth son in person on May 1st, 2011. We'd been in contact I think since 1997 or 1998. I was told to "be patient" – it would happen and it did. (We've moved so much that my search info is in storage somewhere as I've not located it since our last move.)

Since my birth son and I have e-mailed for all of these years, I felt I really knew him and I got over the idea of having one of those "emotional meetings." I always left it up to him to decide where and when to meet. We lived in Maryland and retired to FL, was living there for 3 years, then moved to Colorado for 3 years and it was then that he thought about meeting up in Denver. It just never transpired. Then we moved again from Colorado to Mena, AR and that was definitely not going to be anywhere that he would be going for his work. (He lives in Tacoma, WA).

Just this past Feb, 2011, we sold our home in AR and moved to West Palm Beach, FL. My son e-mailed that he and his wife would be attending a conference in Miami and he would like to drive up and meet me. As it turned out, he met my husband and our daughter. My husband is also the birth father so that meant he met his entire birth family. We met at the Olive Garden for lunch. It was a great first time meeting/reunion. Afterwards I told him I hoped he didn't think I was too standoffish but I just did not want to become emotional in public and he said he didn't interpret it as being standoffish but reserved and he appreciated it as he didn't know how he would have handled a whole bunch of emotion.

He has had a great life, has a wonderful wife and 4 children and they are all very close. We talked a little about why he took so long in meeting in person and he said he had to be certain I was not "a stalker" as that is what happened to one of his adopted sister's. He was the oldest of 4 that his parents adopted and he said he was in school before he ever knew where babies came from. He said every time they got a "new baby" they all piled in the car and headed to the adoption agency and picked up a brother or sister. That was interesting.

JS from Maryland, was the one constant in my search and I give her a lot of credit for her guidance. Also, I was on a birth mother's chat on AOL that prepared me for my search, the ups, the downs, what to expect, what not to expect etc.

I can tell you my experience with Kinsolving could not have been better. It was the best thing for me because I "had to

know." Also, if my b-son and I had met early on, we might not be where we are today. I thought I was prepared to meet instantly but I know God had other plans and the reunion was "perfect."

When he gets his fall schedule he will let me know if they will be returning to Miami again and we'll get together if that is the case.

My son now knows he was loved and where he came from, but most of all he knows I am here to stay. We enjoy each other and he calls me MOM and it still makes me cry. I hope one day all people who were separated by adoption will find the one they lost. The peace my son has today has enhanced him in many ways. When he and my other children get together it is like he was never apart from them. He says he is closer to my kids already in one year then he is with his other family members. That in itself makes me so proud and so very grateful for this miracle in my life.
